Summary of Actions – High Priority Bills



In 2007, the California State Legislature introduced 2,760 separate pieces of legislation. All of these bills were read by staff at CBPA and more than 500 were identified that could potentially impact the commercial, industrial, and retail real estate industry. Below is a summary of the highest priority of those bills and their outcome:

Adds a voice from BOMA California to this board which advises the State Architect on regulatory issues related to historical buildings.	SUPPORT
AB 691	Silva (R-Huntington Beach)	Signed	Extends the operation of the Davis-Stirling Common Interest Development Act, which establishes the regulation of common interest developments. AB 1042	Spitzer (R-Orange)	Signed	Authorizes the clerk of a county board of equalization to accept electronically filed applications for a changed assessment containing an authenticated electronic signature.	SUPPORT
AB 1208	Silva (R-Huntington Beach)	Signed	Sponsored bill. Restores the industry supported Business Improvement Districts law back to its original intention after being changed for political purposes.	SUPPORT
SB 223	Machado (D-Linden)	Signed	Prohibits a licensed appraiser from engaging in any appraisal activity in connection with the purchase, sale, transfer, financing, or development of real property if his or her compensation is dependent on or affected by the value conclusion generated by the appraisal. Requires a state agency that commences construction of a state building, or renovation of a state building, to design, construct, and operate the building to meet, U.S. Green Building Council's Leadership in Energy and Environmental Design for a gold rating. AB 343	Solorio (D-Santa Ana)	Vetoed	Requires the State Department of Health Care Services and the Managed Risk Medical Insurance Board, each year, to collaborate to transmit to the Legislature a report identifying all employers who employ 25 or more persons who are, or support, beneficiaries of certain state welfare programs. Requires the State Board of Equalization to consult with interested parties before prescribing the contents of a change in ownership statement. Provides a penalty caps for nonwillful failure to file. Requires the Board of Equalization to prescribe the contents of the ownership report. AB 843 VETO MESSAGE.	OPPOSE
AB 888	Lieu (D-Torrance)	Vetoed	LEED Mandate – Commercial Buildings. Mandates that commercial buildings over 50,000 s.f. be built to LEED “gold” standards. Shifts the development of "green building" standards for residential, commercial and government buildings from the Building Standards Commission, which considers cost impact in its development of standards, to other state entities, which do not consider cost impact and have no experience in the development or adoption of building standards. Requires the department to prepare, and the board to adopt a schedule for mapping areas at risk of flooding in the Sacramento River and San Joaquin River drainage and a flood control system report for the State Plan of Flood Control. Requires every local coastal government when preparing and adopting a local coastal program for certification by the state Coastal Commission to include a nonpoint source pollution prevention element within its local coastal program. Specifies what the element shall include. Relates to a National Pollutant Discharge Elimination System permit. Authorizes a local government to adopt stricter requirements for land uses and project development than in the permit.	OPPOSE
AB 1452	Wolk (D-Davis)	DEAD/ TWO- YEAR BILL	This bill would enact the Central Valley Flood Protection Act of 2008. The bill would prohibit the board from approving, and the department from providing, funding for any flood protection project that narrows flood channels or reduces the capacity of the flood protection system in the Sacramento-San Joaquin Valley to convey water. The bill would declare that it is the policy of the state that, to the maximum extent permitted by law, the expenditure of funds for flood protection in the Sacramento-San Joaquin Valley reflect specified priorities. Authorizes the San Joaquin Valley district to adopt rules and regulations to reduce vehicle trips in order to reduce air pollution from vehicular sources.
